NUSI strongly demands the release of illegally detained sailors of MT Heroic Idun in Nigeria

Nof India (NUSI) along with the seafarers and their families gathered in large numbers in New Delhi to protest against the illegal detention of innocent seafarers of MT Heroic Idun in Nigeria.

Furthermore, NUSI Delhi Branch Representative, Bro Prakash Thakur met with the Nigerian High Commissioner in New Delhi and raised the plight of Indian seafarers onboard MT Heroic Idun. Apetition demanding the immediate release of the seafarers was also submitted to the Nigerian High Commissioner recently.

At the ongoing ITF Seafarers Section Committee (SSC) meeting, Bro Sunil Nair, Asst General Secretary, NUSI, and representatives from The Maritime Union of India (MUI) raised and condemned the illegal detention in Nigeria. Resulting in a collective motion been unanimously passed in support of the seafarers of MT Heroic Idun.

On the behest of NUSI, thousands of seafarers have also petitioned the ILO and IMO for the release of seafarers onboard MT Heroic Idun from Nigeria.

"NUSI will leave no stone unturned and shall fight consistently for getting our



seafarers back safely from Nigeria," said Mr. Milind Kandalgaonkar, General Secretary -cum- Treasurer, NUSI.

On August 12, authorities of Equatorial Guinea detained 26 crew members, including 16 Indians, eight Sri Lankans, one Pole, and one Filipino, of the large crude carrier on a request by the Nigerian Navy. They were suspected of entering the Nigerian Maritime Environment on August 7 without clearance.

According to the ship owners, the Heroic IDUN ship had entered Nigeria's AKPO terminal on August 8 to load a cargo of crude oil, but the loading operation had been delayed.

night, However, at unidentified craft claiming to be the Nigerian Navy approached the vessel and asked the crew to proceed with them. Unable to identify the craft due to darkness and fearing for the security of the crew, the ship sailed out of the location at full speed.

Three days later, the ship was detained by an Equatorial Guinean naval vessel on the direction of Nigeria.

The crew ashore in Malabo were presented with a resolution on

an September 28 stating the offences committed and the fine to be paid for the same. Hoping an early release of the crew, the ship owners had paid the fine within a week but the crew had been further detained.

> The vessel owners complained that despite not engaging in any unlawful activities, and despite paying the fine, the crew and the ship are still kept under arrest.

> The next hearing of the trial against the crew is scheduled for January 11, 2023.
