## **US** lawmakers look to reinstate tax break for seafood processors

awmakers from the U.S. state of Washington want to fully reinstate a tax break that allows the seafood sector to deduct meals they are required to provide employees at remote seafood processing facilities and on vessels.

**The Remote Seafood Employee** Meals Tax Parity Act is the latest effort by Pacific Northwest lawmakers to restore the tax

#### deduction, which was limited by Congress in 2017.

Seafood processors claim that the loss of the full deduction is a significant cost for their business.

"Members of the Pacific Seafood Processors Association are struggling under the weight of excessive costs, among other challenges, including loss of the tax deduction for the costs of employer-provided meals," Pacific Seafood Processors Association President Julie Decker said.

### SEAFOOD

The Remote Seafood Employee Meals Tax Parity Act would eliminate the 50 percent limitation on the tax deduction for meals provided on fishing vessels, fishprocessing vessels, and fishprocessing facilities located above 50 degrees north latitude that are not within a metropolitan statistical area.

Prior versions of the legislation introduced respectively in 2019 and 2021 failed to gain traction in the U.S. House of Representatives.
