IME(I) Opens Overseas Chapters

aturday 20th August 2022 was a Red Lettered Day in the history of 'The Institute of Marine Engineers (India) [IME(I)]' when it simultaneously opened three overseas chapters in London, Singapore, and Hong Kong.

The opening of these International Chapters of IME(I) marked a fresh approach to research on the intersection between marine engineering and maritime interests of a modern India since the formation of the Institute on 19 Jul 1972, as the India Division Council of The Institute of Marine Engineers (IMarE), London.

IME(I) registered initially on 29 Oct 1977 under 'The Societies Registration Act 1860' at Mumbai has grown into India's largest Its membership is spread across 15 countries from the merchant marine and the Indian / Sri Lankan Navy with over 150 overseas Members.

The opening of these branches was done in a hybrid mode with clockwork

precision wherein Mr. Vikrant Rai, **Engineer & Ship Surveyor-cum-**Deputy DG (Tech) inaugurated the Chapters digitally at MCA Club, Mumbai in absence of Dr. Amitabh Kumar, DG Shipping. Over 200 invitees, dignitaries and members graced the occasion including those attending virtually from pan-India and abroad in different time zones. Mr Rai while congratulating IME(I) on this landmark step towards global outlook, urged the overseas Chapters to contribute to the knowledge quest of IME(I) and the Directorate, and hoped


