

The panel responded to all the questions very well and thereafter Capt. Pradeep Chawla was invited from Hong Kong on the virtual platform to put forward his views.




Seafarers Speakers

that, it moves to India or Vietnam, it's all about how much money the business is making. In the crew wages, the percentile difference is roughly Indian is more expensive by 12 -15% of the other nationalities. The second part which needs to be understood is that crew wages are about 60-65% of the total cost of ship with an Indian crew or

running the ship. This is the most significant part of the budget. All other costs remain generally constant and the only competition between different operators is the Crew Wages. Let's say Indonesia running a ship with an Indonesian crew will be more competitive than somebody running a

Scandinavian crew and that is what the ship owners' competition is in different places. So once you try and educate yourself about the big picture of shipping then maybe you will be willing to accept that there is competition between the different nationalities, Capt. Chawla briefed.

With respect to the cost of courses, Capt Chawla expressed that good companies are having their own training centers or tied up with training institutes and are encouraging a lot of training but again look at the bigger picture, try and look at it from the viewpoint that is education helping the company or is helping individual and he advised seafarers to pay for the value-added courses for the benefit to their career.

Regarding

trauma and confidence building in junior ranks, the industry is thinking about the mental wellbeing of seafarers, so he was confident that this part is going to improve as the industry has become more sensitive towards the mental health of the seafarers and in society the general. It is something we all need to focus on as an industry, he added. He thanked the organizers conducting these forums and giving him an opportunity for seafarers to come and discuss in a frank open manner. In closing remarks, he stressed to be safety conscious, better educated, and better trained and taking ownership of the job, to ensure not to have accidents on board.

satisfaction of seafarers. They also briefed the business module and the key points of being in the market. Thereafter Shri Amitabh Kumar was invited to address his views.

Shri Amitabh Kumar greatly appreciated the concept of organizing these seminars where seafarers are sharing their concerns directly to ship owners/ ship managers through a well-arranged platform and both sides talk to each other and manage each other's expectations within the limitation and resources available. He stressed the importance of On-Job

learning which has no substitute.

On Medical Insurance Scheme for families, he informed that he will work on taking up the medical scheme for all seafarers' families through the Seafarers' Welfare Fund Society and if required to look into increasing the corpus in the Seafarers Welfare Fund Society.

Mental Health, he briefed that he has the **National** asked \mathbf{of} Mental Institute Health & Neuroscience (NIMHANS) to carry out a comprehensive study on the mental health requirement of seafarers of India. The study will look into the requirements right from the induction stage to working on board to the requirements of the family. "There are some institutions that are extending help to seafarers. We have issued the circular in which we have shared the contact details of all these institutions. would be sharing the data that these institutions have,

with NIMHANS so that they have an idea as to what kind of issues they need to address in their study. Hopefully, after the study, we will take a lot of positive decisions in respect of the mental health of seafarers", he assured.

On issues relating to women in seafaring, raised by Ms. Niyari and Ms. Harpreet, Shri Amitabh Kumar said "when it comes to women's seafarer, it is actually an issue which is close to my heart, we need to take care of four stages if we want to encourage more women in seafaring, right from induction to job creation to retention and leadership".

On concern raised for too many jobs on C/O rank, Shri Amitabh Kumar said "To be a leader, you should also know how to delegate".

On the NRI reduction of days, he briefed on the concept of NRI that was brought to make sure one pays tax only in one place. Seafarers' jobs being at sea, is to be considered

exemption from tax.

On Manning Scale- on the Indian flag, he assured to look into and requested ship owners to look into for foreign flag vessels.

On Shore leave, he extended full support that shore leave should not be denied and he informed that more welfare centers are being opened in Indian ports. However Sign-on & Sign-off though are priority areas, unfortunately, all India ports are not equipped sign-on/sign-off with logistics, he added.

Consumer durable makers stock up components amid supply chain worries

With the recent surge in Covid cases in China, consumer durable electronics firms have stepped up focus on stocking up raw materials.

With rising concerns on supply chain disruption, the companies are also working on bringing forward the dates of shipments critical components they closely monitor the situation.

"Some impact supply chains is already visible with shipment delays of about 15-35


days. Less workforce due to Covid impact at factories in China is expected to further increase the pressure on shipments in the coming weeks. I believe higher selling products and stock keeping units (SKUs) may see a more severe impact

such as bigger-sized TVs and premium models of appliances," said Avneet Singh Marwah, CEO. Super Plastronics Pvt Ltd (SSPL).

He added that the company has been focusing on stocking up components especially for TV and appliance products. Companies that make air-conditioners and refrigerators typically begin stocking up on components December onwards ahead of the Chinese New Year holiday period.

This is done to prepare for the summer season that starts from April.

Head of Russia's Admiralty Shipyards Dies Suddenly

Russian major Ashipyard that specializes in building nonnuclear submarines said its general director had died suddenly on Saturday 24 Dec after 11 years in the job, but gave no details.

Admiralty Shipyards, based in the western port of St Petersburg, announced the death of Alexander Buzakov in a statement.

He had been in the job since **August 2012.**

His main achievement. it said, had been preserving strengthening the shipyard's order books for modern non-nuclear submarines, surface ships and deep water vehicles.

Tass news agency said the shipyard is building improved Kilo-class diesel-powered submarines capable of launching Kalibr cruise missiles.

In April, Moscow said it had used a diesel submarine in the Black Sea to strike **Ukrainian military targets** with Kalibrs.

The shipyard said Buzakov graduated in 1980 and had more than 40 years of experience, indicating he had been in his mid-sixties when he died.

St Petersburg is the home city of President Vladimir Putin.

Pakistan boat with Rs 300 crore worth Narcotics seized near Gujarat coast

Pakistani boat with 10 crew members carrying arms, ammunition and 40 kg of narcotics worth Rs 300 crore was intercepted off the Gujarat coast in the early hours of December 26th, the Indian Coast Guard (ICG) said.

Based on specific inputs shared by the Gujarat Anti-Terrorist Squad, the Coast Guard deployed its fast patrol ship 'ICGS Arinjay' for patrolling in the area

close to the International and 26, the ICG said in a Maritime Border Line (IMBL) on the intervening night of December 25

In the early hours of the day, the Pakistani fishing boat 'Al Soheli' was observed moving suspiciously in Indian waters. On being challenged by the Indian Coast Guard ship, the started evasive and manoeuvring did not stop even after firing warning shots, it said.

The Coast Guard eventually managed to intercept and stop the boat. Arms, ammunition and nearly 40 kg of narcotics worth Rs 300 crore were found on the boat. The 10 crew members and

boat are being brought to Okha port for further investigation.


This is the seventh joint operation by the ICG and Gujarat ATS in the last 18 months, and the first apprehension wherein arms and ammunition along with drugs were recovered. A total of 346 kg of heroin worth Rs 1,930 crore has been seized and 44 Pakistani and Iranian crew have been apprehended in the last 18 months, the release said.

Coastal shipping to gets fillip from the Port Ministry

Dromotion of Coastal Shipping is topmost priority of the Ministry under Sagar mala and the ministry has undertaken several initiatives promote coastal shipping in the country.

In order to continue this pace and seek further growth of coastal trade, a perspective plan up to 2025 on development of coastal shipping in India has been prepared by Asian Development Bank according to Port Ministry document released December 27th.

To encourage a modal shift, Coastal vessels are being provided a discount of 40 per cent in port

charges over foreign going vessels. Other measures such as reduction of GST on bunker fuel from 18 percent to 5 percent, Cabotage relaxation for cargo vessels, integration of inland and coastal cargo, Subsidy support to Indian shipping companies, Green channel clearance coastal cargoes and priority berthing for coastal vessels

at major ports are some of the efforts to promote coastal shipping.

Government Of India is providing assistance for construction or upgradation of exclusive coastal berths, platforms or jetties, mechanization of coastal berth, and capital dredging. Five dedicated Coastal Berths have already been constructed at

six are under development at various other ports.

With the advent of Gati Shakti and National Logistic Portal, Coastal shipping will get further required boost and will help in realizing the goal of bringing down the overall logistic cost. The Coastal shipping traffic has grown from 74.9 Million tons in 2014 to 133 Million tons in 2022

Under the coastal Inland shipping and Transport pillar Water of Sagar Mala program, there are various projects which specifically focus promotion of cruise passenger **Up-gradation** transport. and Modernization of International Cruise Terminal at Indira Dock,

Asia-West Coast rates back to normal

The Freightos Baltic Daily Index (FBX) assessed China-West Coast rates at \$1,378 per fortyfoot equivalent unit on

Monday. The index has been relatively unchanged since Nov. 23 and is down 93% from its all-time high in September 2021.

It has now done a full round trip since the beginning of the COVIDinduced consumer boom

— it's back where it was at this time of year in 2019.

The weekly Drewry World Container Index (WCI) assessed Shanghai-Los Angeles spot rates at \$1,992 per FEU as of Thursday. It has been roughly flat since Dec. 8.

It's down 84% from its peak in November 2021, although still \$557 per FEU above where it was in late December 2019.

The Drewry WCI Shanghai-New York index was at \$3,889 on Thursday, down 76% from the alltime high in September 2021. According to the WCI, spot rates in this lane are still \$1,391 per FEU or 56% above where they were at this time in 2019.

East Coast-West Coast price spread normalizes

Long-term rates are tracked by Xeneta. Its longterm contract index held fairly steady in December after falling sharply in November. Xeneta's global contract-rate average is still up 70% year on year this month, and its contract-rate

assessment for U.S. imports remains 130% higher.

"This is really just the quiet before the storm," said Xeneta CEO Patrik Berglund on Thursday. "As more and more long-term contracts expire in the New Year, expect the [Xeneta's long-term index to post far month-on-month greater declines.

"All indicators point toward considerable rate drops from today's levels, with several of the major Far East trades pointing toward new long-term contracts that are much closer to the currently far lower spotrate benchmarks.



SWS awarded by RINA First AiP of LNG/Hydrogen Fuelled VLCC

Registro Italiano Navale (RINA) has announced the Approval in Principle (AiP) of the first very large crude carrier (VLCC) vessel using an innovative propulsion arrangement that reduces the ship's resistance by 5-10%.

This result is achieved by splitting the thrust of a single large propeller into two smaller ones, thus reducing the required ballast draft for the full propeller immersion, which in turn allows the reduction of the volume of the ballast tanks and, ultimately, of the overall ship dimensions and the required power

At the same time the vessel will meet the IMO targets for 2050 through the

use of the ship's fuel (LNG) combined with hydrogen produced onboard. The LNG/hydrogen-fuelled vessel general arrangement developed by Shanghai Waigaoqiao Shipbuilding (SWS) is based on the result of a joint project with Marin, the Liberia Administration, Wärtsilä, ABB and Helbio (a subsidiary of Metacon AB) and RINA.

propulsion The new concept is important because it offers ship owners a way to exceed IMO 2050 carbon reduction targets using practical fuel and technology that is readily available today.

The propulsion design is based on combining LNG

with steam in a Helbio gas reformer to split LNG molecules into hydrogen and CO2. Hydrogen is then directly used to fuel the internal combustion engines and fuel cells. The capture of carbon atom directly from the LNG molecules, serves as a pretechnique, combustion cryogenic the and separation of CO2 from a stream of reformed gases rather than from exhaust emissions results in much smaller installation on bard which eliminates the use of chemicals and the penalty in energy consumption.

The AiP to SWS, following the MR AiP design in Europe, shows the wider acceptance of the concept by global

shipyards.

ostco Wholesale Corp., Home Depot Inc. and Party Holdco Inc. are among companies that pulled back from ship charters amid plentiful space on container ships and fast-slumping oceanshipping rates.

Shipping demand was so great in 2021 that even the nation's biggest importers struggled to secure space on ships. Those that found space paid such a premium, with spot-market rates rising 10-fold to \$20,000 or more to send a container from Asia to the U.S. West Coast, that some retailers found chartered ships an affordable alternative.

Party City started booking space on chartered vessels in mid-2021 in advance of Halloween, its busiest time of year, said Bruce Dzinski, Party City's director of international transportation.

Mr. Dzinski said Party City continued to use chartered ships for 20% to 25% of imports during the first half of 2022, this time routing cargoes through the Port of New York and New Jersey. China Enables Exchange of Seafarers, Even as COVID Surges

midst a growing surge of COVID-19 cases, China is preparing to reopen its ports of entry to foreign travelers - including seafarers - without any quarantine period or testing on arrival.

The new policy will take effect on January 8.

"China will adjust the cargo-only policy at ports of entry and gradually resume entry and exit passengers by land and water and provide greater convenience for Chinese and foreign crew change in China,' Chinese Foreign Ministry spokesperson Hua Chunying on Tuesday 27 Dec . "Those with no issues to report in their health declaration who have been given regular customs inspection and quarantine clearance can enter China without being subject to quarantine."

For more than a year, China's ports have operated on a "closed-loop" model, walled off from the rest of the country by COVID-19

restrictions. That is quickly changing, along with the rest of the nation's approach. After a wave of public protests in November, Beijing quietly loosened its strict quarantine and public health policies, and all indications suggest that the disease is now rapidly sweeping the country.

The government officially maintains that the case rate is low, and its published COVID fatality rate is in the single digits per day for a nation of 1.4 billion; however, social media and independent reporting suggest that hospitals and morgues are having difficulty keeping up with the pace.

The impact on seaports remains to be seen, but early indications suggest

that infection rates are having an effect on all stages of the supply chain. Some manufacturers are slowing production or returning to the use of closed-loop, quarantined staffing policies. Top car manufacturer BYD has had to cut production by a third, and vice president Lian Yubo told CNN that "20% to 30% of our employees are sick at home."

As an indication of the difficulties on the ground, a recent CNBC poll of 340 leading American importers found that about 60 percent having challenges getting their orders filled and delivered - despite the fact that the congestion that plagued ocean freight this year has effectively ended.

After Oil, India Imports Cheap Steel from Russia

Russian steel exports to India rose by 468 per cent between April and November this year, the highest in recent times.

Shipments coming into India stood at 218,000 tonnes for the eight month period under review at \$253 million; while for the same period last year, Russia exported just 38,400 tonnes and valued at \$61 million.

Cheaper offerings, distress selling by mills and a fall in international steel prices, have been major causes of rising imports from Russia and some other key markets like China, Korea and others, a concern that some of the larger steel mills of India have raised over the last few months.

While shipments from Russia saw the highest increase in percentage terms making it the fourth largest supplier; Korea is the largest exporter both in terms of volume and value - to India with nearly 1.5 million tonnes (mt) of steel coming in during April – November, a rise of 16 per cent, a

report of the Union Steel Ministry said.

Other major exporters to India include China, Japan and Indonesia. While China and Indonesia saw an year-on-year (y-o-y) by 69 per cent and 3 per cent, respectively; shipments from Japan fell by 6 per cent.

Overall imports of total finished steel at 3.751 mt, up by 22.5 per cent, y-o-y. Indian steel imports have increased y-o-y for six months of the year – from June to November with quantity varying between 444,000 tonne to 600,000 tonne.

Items brought in from Russia include hot rolled coils and strips to the tune of 158,400 tonnes; around 9200 tonnes of galvanised plain and corrugated sheets (GP/GC sheets); 50,400 tonnes of electrical sheets and 100odd tonnes of other items.

In value terms, semi-finished steel from Russia was worth \$2.9 million; while finished steel imports were valued at \$250 million.



The new ports will play a significant role in boosting export-import trade with India through roads, making the transportation of perishable goods faster.

Rupee Trade Makes a Head Start with Russia

ettlement of foreign trade in rupee has finally taken off, with a few transactions involving Russian firms having taken place recently, trade sources told FE. This is the first set of transactions since the Reserve Bank of India (RBI) introduced guidelines in July to promote the settlement of international trade in rupee.

At least a dozen-and-ahalf vostro accounts have been opened so far to facilitate the rupee trade with not just sanctionshit Russia but also Sri Lanka and Mauritius. So, more such transactions are likely to take place in the coming months, said sources. This may spur exports to Moscow, which declined 16% until October this fiscal from a year ago to \$1.6 billion due to the delayed flow of payments, despite renewed interest shown by Moscow to source more goods from India, they added.

30-35 countries, including those from Asia, Scandinavia and Africa, have expressed interest in better understanding the proposed rupee trade mechanism for possible adoption. These countries include neighbours, such as Sri Lanka, Bangladesh, Nepal and Myanmar, which have been grappling with a shortage of dollar reserves. So, there is a huge scope to boost the rupee trade, senior government officials believe.

Russian banks like Sberbank, VTB, Gazprom, BCS, MTS, Tinkoff, Soyuz, **Credit Europe Bank** (Russia), PSCB, Ros and **JSCB** have opened such accounts.

Six of these accounts

have been opened with IndusInd Bank, and one each with UCO Bank, HDFC Bank, Union Bank of India and Canara Bank. Sberbank and VTB has opened one such account with their local branches

The RBI had, in July, notified the mechanism not just to reduce the pace of depreciation of the rupee against the dollar but also internationalise domestic currency. Subsequently, the commerce ministry notified guidelines to enable exporters to get stipulated benefits under the foreign trade policy even if the export realisation is in the domestic currency, and not dollar.

Another land-port -Tegamukh of Rangamati - is under consideration,
