Coastguard acts to save the life of a Mariner at sea

he Indian Coast Guard's (ICG) advanced light helicopter has evacuated an injured Myanmar national from a vessel of Singapore, about 80 nautical mile (148 km) east-northeast of Paradip.

Motor tanker Venture had developed a mechanical snag and was anchored about 40.5 nautical miles south of Sagar. A crew member Than Htike Lwin sustained blunt abdominal trauma while carrying out maintenance of a hydraulic pipeline.

Lwin complained of severe pain in the abdomen and also faced difficulty in breathing. The master of GB Venture vessel, which was reportedly carrying oil to Haldia, requested Sagar vessel traffic management

system for his immediate evacuation.

The Indian Coast Guard Air Enclave in Bhubaneswar deployed an advanced light helicopter (ALH) to evacuate him. Two coast guard ships operating in the sea were also diverted towards the motor tanker to render necessary assistance.

The ICG's helicopter arrived at the vessel and evacuated Lwin from the vessel in a 20 minute operation. He was brought to Bhubaneswar and shifted to a private hospital here. Lwin's health condition is stated to be stable.

Centre Invites Bids For ICTP Port Project

he Centre invited bids for

₹41,000-crore mega international container transshipment port (ICTP) being planned for the Galathea Bay of Great Nicobar Island of Andaman and Nicobar Islands.

The government aiming to complete the terminal in 2028 with a handling capacity of million twenty-foot equivalent units (TEUs). A TEU is an approximate unit of measure used for cargo containers.

Yet another ferry service to operate between Mumbai and Navi Mumbai

Tayan XI, a luxury vessel belonging to the Nayantara Shipping, has been permitted to operate services between Belapur in Navi Mumbai and Gateway of India. State ports minister Dadaji Bhuse will inaugurate the service on February 4

MyBoatRide.com in collaboration with Nayantara Shipping will operate the ferry services. The vessel has a capacity of 140 passengers on the lower deck and another 60 on the upper/business class deck.

The vessel will sail from Belapur in Navi Mumbai at 8.30am and reach Gateway of India at 9.30am. The second trip

from Gateway of India will depart at 6.30pm and arrive at Belapur at 7.30pm. The service would help passengers reach Mumbai

from the suburban Navi Mumgai in the morning and reach back home in th evening

Tickets will be priced at Rs 250 for the lower deck and Rs 350 for the upper/business deck. To ensure last-mile connectivity from Belapur station, sharing rickshaws will be available to the jetty at Rs 10 and, cabs and buses will be available from Gateway of India to Churchgate and CSMT. High costs of ferry service and lack of last mile connectivity have come in the way of these operations becoming successful in the past.

A spokesman of the shipping company that will operate the ferry service said, "We brought Nayantara ship in October and we have been pursuing get permission. At present, we operate Belapur to Mandwa via domestic cruise terminal on weekends. We are hoping to attract the office crowd.

At present, it takes two hours by private taxis from the city to Belapur and they charge Rs 800. Our pricing and journey time are much lesser." The company had been asking for permission to operate its services and there was stiff opposition from traditional passenger boats.

Spanish Police Seize Cocaine Worth \$114 Million from Cattle Ship

The new port named the "LEKKI SEA PORT" is 75% owned by China **Engineering Company and the Tolaram** Group. The remaining 25% is owned by the Lagos State government and the Nigerian Ports Authority.

The port is designed to handle 1.2 million containers annually. It is the largest seaport in Nigeria and one of the largest in all of West Africa. The construction of the port began in June 2020 and was initiated by the incumbent president of Nigeria, Muhammad Buhari. The **LEKKI PORT** is a great endorsement of

China's Belt and Road cooperation in Africa.

China has been one of the largest bilateral lenders to Nigeria and has funded many railroads and power stations. Cai Jianchun, the Chinese ambassador to Nigeria called the new port a game changer, and further added that the port would create around 200,000 new jobs.

Reefer Rates Fall On Main Europe To Far East Trade

ccording to the latest data from Oslo's Xeneta, the spot rate on the leading fronthaul reefer route now sits at USD 4 240 per FEU.

traditionally The resilient trade in reefers from Europe to the Far East appears to be slowly succumbing to the same market forces as the rest of the containerized ocean freight sector, with sustained declines volume now being followed



According to the latest data from Oslo's Xeneta, the spot rate on the leading fronthaul reefer route now sits at USD 4 240 per FEU. After a period of almost two years defined by prices in excess of USD 5 000 per FEU reefer container, a sharp fall in December has changed the character of the market, with spot rates now below-contracted prices for the first time since October

Xeneta's crowd-sourced data shows a current longterm rate just shy of USD 4 500 per FEU reefer, after

by spot and long-term rate peaking in September last year at USD 4 850.

Here Sand points out that reefer volumes from Europe to the Far East peaked back in 2020, and have been declining ever since. Volumes fell by 4% in 2021, accelerating to a 13% drop in 2022. This equates to a loss of 100 000 TEU from January to November 2022.

Despite the declining rates, Xeneta's historical data shows that prices remain "relatively strong". In the third quarter of 2019 long-term reefer contracts could be signed for "only" USD 2 000 per FEU.

River cruise MV Ganga Vilas Leaves Kolkata for Sunderbans

V Ganga Vilas the river cruise which took off from Varanasi, docked at a Kolkata jetty for the last two days, left for Sundarbans, a UNESCO heritage site on January 30th, an official said. The cruise vessel, flagged off by Prime Minister Narendra Modi on January 13, entered West Bengal early this week through Murshidabad and later reached Kolkata, he said. The ship has been docked at the Indenture Memorial (IM) Jetty on the bank of the Hooghly river.

The vessel left Kolkata on January 30th and then it will be anchored at Sundarbans, one of the largest mangrove forests in the world and a UNESCO world heritage site, for two days," the official said.

Taking to Twitter, Union Shipping Minister Sarbananda Sonowal said, "The next phase of the journey


of MV GangaVilas will be on the Indo-Bangladesh Protocol Route, as it travels through Bangladesh to reach Assam. All infra has been provided at IM Jetty in Kolkatta for a smooth immigration process for passengers."

MV Ganga Vilas began its journey from Varanasi in Uttar Pradesh on January 13 and would travel around 3,200 km in 51 days to reach Dibrugarh in Assam via Bangladesh, sailing across 27 river systems in India and the neighboring country. From the eastern Uttar Pradesh town of Varanasi the cruise moved to Patna in Bihar and reached Kolkata through Jharkhand.

Tourists, who are travelling on the maiden journey of the cruise, had a visit to Kumartuli, an idol-making hub in Kolkata on Saturday. "A city tour was planned for the passengers so that they can experience local culture," the official added.

s many as 352 vessels crossed the Suez Canal from both directions in December 2022 according to official release from the Suez Canal authority.

The release said the Port Said port received 36 container ships with a capacity of 277,720 tons. The port also received

10 general cargo ships, 10 liquid bulk ships, and two (RORO) roll-on/roll-off ships, among others.

Meanwhile, East Port Said Port witnessed 113 container ships, 9 clinker ships, 9 salt ships, and 3 cement ships, with a capacity of 3.85 million tons. Also, Al-Arish port received 11 ships exporting bulk goods to foreign markets, with a capacity of 40,153 tons.



European Union announces a full ban on Russian Oil from Feb 5

European Union has announced a full ban on Russian oil product imports from Feb. 5 in an attempt to cut Russia's revenues for its role in the military conflict with Ukraine.

The Group of Seven (G7) coalition is also planning to impose price caps on Russian fuel.

Russia has plans to divert its supplies to Asia, Africa and Latin America,



and would rather cut oil production than agree to a price cap, Russian Deputy

Prime Minister Alexander Novak said in December.

Diesel supplies from

Russian ports to Turkey have been growing in recent months and totaled about 0.68 million tons from Jan. 1-25, against 0.73 million tons in whole December, Refinitiv data showed.

Russia has diversified its sources for export in view of the sanctions regime being implemented by United States, European union and Japan. Two cargoes carrying 70,000 tons of diesel are also heading from Russia to

Since the start of January, diesel and gasoil supplies from the Russian Black Sea port of Novorossiisk to Senegal have ramped up to 140,000 tons versus 35,000 tons in the previous month. Two more tankers could deliver up to 66,000 tons of Russian diesel to Libya, Refinitiv data showed.

Despite the growing oil product supplies from Russia on new export routes, traders expect some turbulence on markets for the next two to three weeks, market sources said.

Fight months into a free trade agreement with the United Arab Emirates, India's trade gap with the Gulf nation has widened by more than \$5 billion, lifted by elevated global crude oil prices and an increase in non-oil trade.

While India's exports to the UAE grew by 11% during this period to \$20.25 billion, imports climbed **24.4%** to \$36.23 billion, data from the department commerce showed. This caused a trade gap of \$15.98 billion, compared to a deficit of \$10.89 billion in the corresponding period last year.

India's non-oil trade deficit more than doubled May between and December 2022 to about \$2.2 billion from \$1.01

billion a year earlier. The India-UAE comprehensive economic partnership agreement (CEPA) came into force on 1 May 2022.

India's non-oil outbound shipments to the UAE grew by 2.59% to \$15.03 billion, while nonoil inbound shipments jumped 10.03% to \$17.23 billion during the May-December period.

An official in the department of commerce said CEPA utilization is "on an uptrend" and is only likely to increase further. Pointing at the increasing utilization of the free trade pact by Indian exporters, the official said the issuance of preferential certificates of origin (COO) under the CEPA increased from 415 certificates worth \$133.2



million in May 2022 to 6111 worth \$1.11 billion in December 2022.

However, while the import surge was largely led by high-value petroleum products and raw material shipments, exports have been led by double-digit expansion in gems and jewellery, electrical machinery and equipment, automobiles, cereals, etc., where India gained duty-free access under the agreement. That, experts, pointed out, was a good start.

The pact, negotiated in a record 88 days, was signed on 18 February. It is the first major free trade pact signed by the Narendra Modi-led government since it came to power in 2014 and is likely to benefit about \$26 billion worth of Indian products that are subjected to 5% import duty by the UAE.

While imports of crude oil surged 60% in April-November to \$20.12

billion, imports of polymers were up 30% to \$1.09 billion.

The pact immediately eliminated duties for 90% of India's exports in value terms to the UAE, covering sectors such as gems and jewellery, textiles, leather, and engineering goods among others.

Gems and jewellery exports to the UAE grew by 33% in May. It grew 18% during the June to December period to \$3.38 billion. Electrical machinery and equipment exports expanded by 28% to \$2.25 billion in the same period. While automobiles and cereals exports grew by 35% and 39%, respectively, that for machinery and electrical appliances expanded by 17% in this period.



Rise of a container terminal developer

The Mumbai based Man Infra - construction Limited MICL has bagged the contract to develop the Fourth Container terminal at Jawaharlal Nehru Port Authority (JNPA). . It is an honor for the company to be involved in the construction process of phase 1 with a development area of 90 hectares and phase 2 with a development area of 105 hectares of this prestigious project. Phase 1 was constructed in June 2018 and Phase 2 which commenced in April 2022, which will soon be completed within stipulated time. BMCT will be India's largest container terminal with cutting-edge handling capacity and an estimated investment outlay of Rs.

7,9351 crore spread over eight years for two phases, according to JNPT.

MICL, as part of its legacy, prides itself on constructing the first private port in India, well known as Nhava Sheva International Container Terminal also known as the Jawaharlal Nehru Port Trust (JNPT), a development of 20 hectares completed in November 2000

After delivering the high quality work standards, the MICL Group also constructed the Chennai Terminal, Container a development of 15 hectares with completion by June 2005 and Mundra International Container Terminal- MICT, over a land parcel of 23 hectares, completed in March 2006. These projects included major onshore works as

well as basic construction work such as stonework, the building of pavements, and asphalt work, among others.

In November 2010 the company constructed India's first International Container Transhipment Terminal at Kochi on 30 hectares of land parcel. The first private port in India to be built using the PPP model is Gujarat Pipavav Port Ltd (APM Terminals Pipavav). The construction of this port was completed by MICL Group in March 2016.

In the making of the MICL legacy, the group has made significant contributions to the infrastructure sector with the construction of major ports across India, which includes reclamation works, railway works,



construction of container terminal and other port substantial works. 

Amended berthing rule at Deendayal Port

If there is no taker for the berth, the vessel will be permitted to continue until the completion of cargo operations, under three times additional berth hire charges until it vacates the berth, according to a release



How Adani group responded to US firms allegations

Adani Group which has a major presence in the Indian Port sector calls Hindenburg Research the "Madoffs of Manhattan" and says the report published on January 24th is "nothing but a lie". "The document is a malicious combination of selective misinformation and concealed facts relating to baseless and discredited allegations to drive an ulterior motive. This is rife with conflict of interest and intended only to create a false market in securities to enable Hindenburg, an admitted short seller, to book massive financial gain through wrongful means



at the cost of countless investors," said Adani Group in the statement.

After Adani Group published a 413-page "detailed response to Hindenburg's unsubstantiated accusations", the US-based short-seller has responded by saying, "fraud cannot be obfuscated by nationalism or a bloated

response that ignores every key allegation we raised.

The Group goes on to add that Hindenburg Research's allegations are "not merely unwarranted attack on any specific company but a calculated attack on India, the independence, integrity and quality of Indian institutions, and the growth story and ambition of India."

"Hindenburg has not published this report for any altruistic reasons but purely out of selfish motives and in flagrant breach applicable securities of and foreign exchange laws," it said. "The report is neither 'independent' nor 'objective' nor 'well researched'."

raised by Hindenburg relate to matters that have been duly disclosed by Adani portfolio companies, Adani Group said. "Of the balance 23 questions, 18 relate to public shareholders and third parties (and not the Adani portfolio companies), while the balance 5 are baseless allegations based on imaginary fact patterns."

Adani Group listed questions from the report dismissed and them as "false suggestions based malicious on misrepresentation governance practices" or "manipulated narrative around unrelated third party entities" or "biased and unsubstantiated rhetoric".

"We reaffirm in compliance we are with all applicable laws

65 of the 88 questions and regulations. We are committed to the highest levels of governance to protect the interests of all our stakeholders," it said. "The Adani Portfolio also has very strong internal controls and audit controls. All the listed companies of Adani Portfolio have governance robust framework.'

> Adani portfolio and the Adani verticals are focused on contributing to nation building and take India to the world, it said. "We will exercise our rights to pursue remedies to safeguard our stakeholders before all appropriate authorities and we reserve our rights to respond further to any of the allegations or contents of the Hindenburg report or to supplement this statement," it added.

The consultant selected has to obtain statutory clearances and assist in conducting bid process management for proposed development model for the greenfield airport. 

IMO hosted "Maritime Single Window 2024 - A window of opportunities"

rom 1 January 2024, it will be compulsory for ports around the world to operate Maritime Single Windows (MSWs) for the electronic exchange of information required on ships' arrival at a port, their stay and their departure. This mandatory change follows the adoption by IMO's **Facilitation** Committee of amendments to the **FAL Convention.**

With this key mind, IMO date in hosted "Maritime Single Window 2024 – A window of opportunities", a two-day



Symposium (18-19 January 2023) jointly organized by IMO, <u>IAPH</u> and <u>BIMCO</u>, with the support of Port International Community **Systems** Association (IPCSA).

A host of experts from across the shipping and ports sectors explored how MSWs fit with national digitalization strategies, the

best approach to designing and implementing MSWs to suit Member States' maritime trade facilitation objectives and objectives to achieve the greening of shipping.

Also discussed were the concept of interoperability and understanding how to apply industry standards to harmonize electronic

data exchanges, as well as port call data requirements, and the development of strategic partnerships.

Opening at IMO's Symposium headquarters, London IMO Secretary General, Mr Kitack Lim, said that making MSWs mandatory from 1 January 2024 was not only "a significant step towards accelerating digitalization in maritime trade", but also "an opportunity for all stakeholders in shipping, and a necessary step forward".

Mr Lim said, too, that taking this step would accelerate the digitalization decarbonization

aspirations of international shipping. He praised the progress made in recent years by the shipping and port industries and pledged IMO's support to Member States in finding tangible solutions to the forthcoming new obligations under the FAL Convention.

In his opening remarks IAPH's President, Subramaniam Karuppiah, warned that COVID-19 pandemic emphasized that the maritime industry is seriously lagging behind in its move to digitalization. **Nikolaus** President Designate of BIMCO. sounded optimistic note, describing MSW as "an opportunity to be exploited and one we cannot afford to miss".

Emergency declared to Cochin airport

The incident occurred hours after a suspected bird hit forced a Kolkata-bound Air Asia flight with 180 passengers and eight crew members on board to abort its take-off at the Lucknow airport.

The pilot of Air Asia flight suspected the bird hit during the take-off roll. The aircraft returned to the bay and all the passengers were de-boarded safely." The aircraft was grounded for detailed inspection. Impacted guests were attended to and we are making all efforts to mitigate the impact on the integrity of other scheduled operations.

The presence of birds around the runway has remained a big challenge for the Lucknow airport. In the past, incidents of animals such as jackals and hyenas intruding the runway have come to fore.

China thwarts Sri Lanka's move to get IMF loan

China has declined to accept conditionalities imposed by the International Monetary Fund thereby setting at naught Sri Lanka efforts to avail of the large tranche of loan offered by the fund to get over its economic woes

The Chinese Export-Import Bank has made it clear to Colombo that it will only provide repayment moratorium for only two years instead of 10 years moratorium as recommended by IMF-Paris Club. The IMF and Paris Club have recommended that the restructuring

of Sri Lankan debt should be carried over 15 years.

The Export-Import Bank of India however has given in writing that its financing and debt relief to Sri Lanka will be in tune with the

IMF and Paris Club. India in its letter to IMF Executive Director Kristalina Georgieva on January 16, 2023, made it clear that it would fully support debt sustainability analysis by IMF and Paris Club without any additional conditions

This means that the IMF package of 2.9 billion US dollars (spread over four years with six monthly reviews) to Sri Lanka in March is in jeopardy due to Chinese EXIM Bank conditions.

Sri Lanka owes at least 7 billion US dollars to China in debt including loans from the Chinese Development Bank with the

numbers reaching another level if private debt is also included. The unsustainable high interest debt is on account of financial malfeasance and mis-governance by the Rajapaksa regime, of which current President Ranil Wickremesinghe was also a vital part in the past.

Thanks to financial profligacy by the Rajapaksas, Chinese high interest money was used to build unsustainable white elephant projects all over the country including Hambantota port, Mattala Rajapaksa International Airport and Norocholai power station. The public resentment that spilt over against the Rajapaksas in 2022 has allowed left political parties to rise in the Island nation.
